COUNCIL PRESENT

Fred Davis made a motion and John Ballard seconded to approve the bid from Hudson Paving for the following: Rutherford Street -\$63,330., Harlem Heights Morven Road to \$52 South - \$18,855., Harlem Heights 52 to dead end - \$63,995., Threadgill Street - \$36,980., and West Wade Street - \$42,695.
